- A. School Improvement Plan
 - I. SIP reviewed
 - The legislature has proposed funding for Acadience licenses for K-6. If this is not passed, Acadience provides a report for \$1/kid that Adrienne will pay for so that all kids' data will be tracked.
 - We will begin providing parents a letter that better explains the Acadience Home Connection Letter.
 - District Projection: 33 ½ down to 31 FTE, 28 Kindergartners per class. We can buy half of our cheapest teacher at \$35,000 which would allow Kinder numbers to be around 21.
 - Suggestion for next year will be to have LCMT and DATA team meetings happening at the Grade Level PLC Meetings.
 - CMI Lesson Study explained for parents.
 - Added Goal #3 Social Emotional Learning, staff will be trained using Pure Edge, Inc. We could use TSSP funds to buy out the counselor's salary in order to make her an FTE. Spaces for students are set up already in Kennett's, and Gleed's offices. Additional spaces will need to be set up. Daily mindful minutes will be encouraged.
